2. Closing comments by Commissioners and/or Judge, if any.

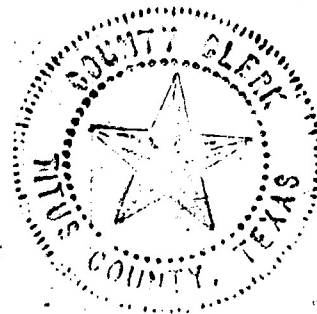

Judge Sam Russell opened the meeting at 10:06 A.M. stating that a copy of this public meeting notice was posted on the 13<sup>th</sup> of January, 2007, in compliance with the Open Meeting Act of a seventy two hour posting before the meeting.

The purpose of this meeting is to allow public comments on the proposed county road map according to the 257 Transportation Code, House Bill 1117 passed in 2003. A set of county road maps will be available for public inspection. This will allow the property owners along the roads on these maps to protest. There are also protest forms available if anyone wants to fill one out.

No one was present for public testimony or to fill out protest forms.

Judge Russell said no Commissioner has a key to the Courthouse and he has had a key made for each of them. Commissioner Hockaday said he did not have one because he didn't ask for one.

Judge Russell also said there will be a door put in the Auditor's Office to free up the mail area so anyone could check the boxes at any time.
