#### COMMISSIONERS' COURT OF TITUS COUNTY, TEXAS SPECIAL MEETING May 24 2010

Judge Sam Russell called the Special Meeting to order at 9:10 a.m. on May 24, 2010 stating that for the record, notices had been posted 72 hours preceding the meeting as requested by the Open Records Act.

Judge Russell led the Commissioners' Court in the Pledge of Allegiance. Commissioner Don Boggs followed with the invocation.

1. Public Comments and/or Requests for Information on Non-agenda Items in accordance with Section 551.042, Texas Opens Meetings Act

There were no public comments and/or requests for information on non-agenda items.

2. Review Minutes for Special Meeting April 26, 2010, May 10, 2010 Regular Meeting and May 17, 2010 Special Meeting

Commissioner Don Boggs asked that on the April 26, 2010 minutes the name be corrected on item 11, Closing comments, to Ed Gillespie instead of Ted Gillespie. Also, to add those in attendance that was left off. He also asked that she check for grammatical errors before sending minutes to be approved. Ms. Price assured the court that this would be done.

Motion was made by Commissioner Don Boggs and seconded by Commissioner Thomas Hockaday to table the minutes until corrections were made. Motion carried unanimously.

**3.** Consider and Possibly Approve Preservation of Divorce Judgment; Divorce Minutes and Civil Minutes from District Clerk's office to be taken from Records Management

Debra Abston, District Clerk, came before the court with a request to preserve the following books: Divorce Judgment 1 - \$934.00; Divorce Minutes 2 - \$867.00 and Civil Minutes (will be returned in two books) - \$1724.00. Ms. Abston stated that these books are of historical value dating back to 1895 and are falling apart with the pages being very brittle. A backup will be stored in Dallas at the company who is preserving the books.

Motion was made by Commissioner Mike Fields and seconded by Commissioner Phillip Hinton to approve preservation of Divorce Judgment; Divorce Minutes and Civil Minutes from District Clerk's office to be taken from Records Management. Motion carried unanimously.

# 4. Consider and Possibly Approve Filing System for District Clerk's Office to be taken from Records Management

Ms. Abston explained that she is out of filing space and brought before the Commissioners' Court two options of filing systems for the basement:

Option 1 – This option contains 2 rolling carriages and two stationery carriages and holds 5040 filing inches or the equivalent of 41 five drawer file cabinets. Price is \$13,068.00

Option 2 – This option contains one stationery carriage and three rolling carriages and holds 5880 filing inches or the equivalent of 47 five drawer file cabinets. Price is \$13,710.00

County Auditor, Carl Johnson, informed the court that there was only \$11,000 in Records Management and the rest would have to be taken out of General Accounting. There is plenty of money in the County Clerk's Record Management account but wasn't sure if this could be used for District Clerk expenses.

Motion was made by Commissioner Thomas Hockaday and seconded by Commissioner Phillip Hinton to approve the purchase of Option 2 at a cost of \$13,710.00. Motion carried unanimously.
