- 2) Consider and possibly approve Minutes from November 28, 2011 Special Meeting of the Commissioner Court. (Listen to audio track 1, 00:01:07).

Motion made by Commissioner Boggs and seconded by Commissioner Hockaday. Motion carried unanimously.

- 3) Presentation by Charlie Smith with the Industrial Foundation regarding Freeport Exemption and Warehousing Exemption for Local Ad Valorem Taxes. (Listen to audio track 1, 00:01:34 and/or see attachment #1).
 - a. Judge Lee: I have asked Charlie Smith with our Industrial Foundation to come and speak today about a subject that you all were exposed to about a week ago when we had our meeting up at the extension office. This matter involves whether or not we should enact a resolution having to do with Freeport Exemptions, Warehousing and new Legislation that would allow our local companies to house inventory and thereby avoid the Ad Valorem Taxes. There are pros and cons and we heard a recommendation from Jim Allison, General Counsel for Texas Association of Counties reminding us that we have until December 31, 2011 to enact that resolution. However, before we just move forward at his recommendation, I wanted you to hear from Charlie Smith who may have a different viewpoint. I think that you are better able to make a decision if you hear both sides about it.
 - b. Charlie Smith references the attached Memo, attachment #1.
 - c. Judge Lee: If you want to make a move, like the Hospital and College have done, we will draft a resolution, which has been provided to us by Mr. Allison, and we will enact that in the next meeting two weeks from now, which will be prior to year end. That will prevent anyone from being able to take advantage of this. Again, you are protecting us from a problem that right now does not exist because of the nature of our primary manufacturers....
