On February 21, 2012, PTP Transportation (PTP), on behalf of Titus County, advertised for bids for the above referenced project. On Tuesday, March 13, 2012, Titus County accepted bids. A total of six bids were received and PTP publicly read the bid submittals. Upon review of the bids, PTP has determined that H. H. Howard and Sons, Inc. is the lowest and most responsive bidder with a bid amount of \$8,512,733.79. For your review, I have attached the bid analysis and the Request for Concurrence, which was submitted to the Texas Department of Transportation on March 14, 2012.

THIS AGREEMENT is made this 13<sup>th</sup> day of March, 2012, by and between Titus County, Texas, a political subdivision of the State of Texas, hereinafter called, "COUNTY" and H. H. Howard & Sons, Inc.

a General Contractor, whose principal place of business is located at 728 CR 2225 Daingerfield, TX 75638, and is hereinafter called "Contractor."

WHEREAS, COUNTY has awarded to Contractor a contract for the construction of a Public Works Project generally described as THE CONSTRUCTION OF A NEW LOCATION NON-FREEWAY FACILITY CONSISTING OF GRADING, STRUCTURES, BASE, SURFACING, SIGNALS AND PAVEMENT MARKINGS FROM US 67 AT FM 1001, SOUTH TO SH 49, FM 2348 and being more particularly described in the plans and specifications accompanying this agreement, and;

WHEREAS, Contractor has agreed to construct such Public Works project in conformity with the plans and specifications and to supply all necessary labor and materials at the prices set forth in the bid form submitted by Contractor and accompanying this agreement;

NOW THEREFORE be it agreed by COUNTY and contractor as follows:

2. It is expressly understood and agreed that COUNTY has available the total maximum sum of funds hereinafter certified available by its COUNTY Auditor for the purpose of satisfying County's obligations under the terms and provisions of this agreement; that notwithstanding anything to the contrary or that may be construed to the contrary, the liability of County is limited to said sum, plus

additional amounts of funds from time to time certified, available for the purpose of satisfying County's obligations under the terms and provisions of this agreement. Should County, without cause, fail or refuse to pay Contractor any consideration due under this agreement or fail to refuse to appropriate such additional funds, if any, as may be required to complete the contract work, then the sole and exclusive remedy of Contractor shall be to terminate this agreement and take possession of any goods or materials not then complete in place and for which County had not previously paid the consideration established under this agreement.

- 3. This Contract, including all items listed under Number 1, contains the whole agreement between the conditions, or collateral agreements, other than those expressly set forth herein.


Mr. Radcliff:

Titus County received bids for the above referenced project on March 13, 2012. The engineer's estimate for this project was \$10,654,798.69. Six bids were received. The lowest and most responsive bidder was H. H. Howard and Sons, Inc. with a total bid amount of \$8,512,733.79. For your review, I have attached the bid analysis.

As you can see from the attached analysis, five bidders were below the engineer's estimate. The deviation between the engineer's estimate and the low bid was approximately 20.10%. The variation in price for excavation, embankment and mobilization contributed to this deviation. This group of bidders, specifically the low bidder - H.H. Howard and Sons, has local knowledge that would allow such aggressive pricing. Titus County respectfully requests TxDOT to concur on the award to H. H. Howard and Sons, Inc.

## MEMORANDUM

---

### **Status**

To keep the Titus County Commissioners Court fully updated as to the progress of the Titus County Pass-Through Program, PTP Transportation (PTP) offers the following status report.

### **Environmental**

#### *Groundwater Contamination*

Test results for the "Ghost Tank" removal on the former Cameron Auto Sales site were obtained and showed contamination of the shallow groundwater at the site. Preparation of the UST Removal and Release Determination Report was completed to and will be submitted to Texas Commission on Environmental Quality (TCEQ) on March 16. PTP will wait for TCEQ to review the report before proceeding with the installation of additional monitoring wells. In the meantime, the contaminated soil removed from underneath the piping leak will be tested and classified for landfilling. This will allow the soil to be landfilled and the slabs to be removed.

### **Right of Way**

#### *FM 1000*

Right of way acquisition for the FM 1000 project is ongoing. Two important parcels, JayTex and Tractor Supply, are scheduled to close within the next 10 days. The remaining seven (7) parcels are scheduled for condemnation. All parcels should be obtained, either through acquisition or condemnation, by April 29. This will allow for the letting of the FM 1000 project by the first of May.

## **Construction**

### ***US 271***

Progress on the road construction continues. As of March 14, 65 total working days had been charged against the total 663 contracted working days. Since the start of construction 21 rain days have been recorded.

The project has seen modest but steady progress over the past two weeks. Major storm sewer construction has been completed by North Texas Construction in preparation for embankment operations. Bridge foundation stabilization operation (stone columns), being progressed by Hayward Baker, is nearing 75% completion. Embankment operations have begun in earnest on the mainlanes of US 271 on the south end of the project, directly adjacent to the Prefiert property. This work is being handled by dirt work subcontractor, T.J. Lambrecht. The prime contractor, Williams Brothers, has completed set-up of their pug mill (sand plant) and is moving towards set-up of the concrete plant. The recent rains this past weekend, almost 4 1/2 inches, will result in a minor setback, but the contractors are confident they can regain any lost time with some good weather.

### ***FM 2348***

On February 21, 2012, PTP Transportation (PTP), on behalf of Titus County, advertised for bids for the above referenced project. On Tuesday, March 13, 2012, Titus County accepted bids. A total of six bids were received and PTP publicly read the bid submittals. Upon review of the bids, PTP has determined that H. H. Howard and Sons, Inc. was the lowest and most responsive bidder with a bid amount of \$8,512,733.79. For the Court's review, PTP has distributed the bid analysis and the Request for Concurrence, which was submitted to the Texas Department of Transportation on March 14, 2012. Upon the execution of the contract, H. H. Howard will have 30 days in which to place payment and performance bonds with the County. At that point, a preconstruction meeting will be scheduled and a start date for construction will be agreed upon.
