6. Presentation by Steve Austin, Veterans' Service Officer

A bronze medal award was presented to the family of World War II Veteran, US Army PFC Charlie H. Peckham, as a result of his service in Italy where he was an anti-tank gunner. Mr. Peckham was awarded the Combat Infantry Badge for exemplary conduct in action against the Germans in Europe and for meritorious achievement in combat against a determined enemy on May 11, 1944 and again on June 9, 1944. His daughter, Virginia Tabor, was present along with other members of his family to receive this award. Taps was played at the end of the presentation.

Leonard Rockwell, Elections Administrator, explained that the goal of the grant application to the Federal Voting Assistance Program is to provide military and overseas voter with the opportunity to receive their ballots online and meet the 45 day deadline to be returned by regular mail due to faster access to their ballots. It is fully funded for the first five (5) years by federal funds. Each participating county will be covered under the License Agreement between Rockwall County (as the Consortium leader) and a private vendor. (See Attachment #3)
