Proposal Summary

The Titus County Historical Commission (TCHC) and the Titus County Historical Preservation Society (TCHPS) request that the Titus County Commissioners Court reconsider the acquisition of the "Old Post Office/Library" building located at 213 North Madison, Mt. Pleasant, Texas. The building shall be used for the TCHC, the County Veteran Service Officer, the TCHPS, and others.

The desired result would be that the City of Mt. Pleasant/Council and Titus County Commissioners Court could arrive at a mutually satisfactory agreement for the perpetuation of the building as a working office, a center of historical preservation, and venue for learning and community interaction.

Goals

The goals for this historical building and site are:

- preserving one of the few remaining historical buildings in Titus County;
- maintaining the downtown business traffic and interests;
- educating of children and adults about the history of Titus County and Texas; and,
- promoting tourism within the county.

Target Population

The "Old Post Office/Library" shall be used for educational purposes for all residents of Titus County. The building shall be made available for all schools for learning purposes, for community meetings, and for tours. The TCHS and the TCHPS shall involve community groups throughout the county to support the historical efforts.

Budget and Future Funding

If an agreement could be reached between the City of Mt. Pleasant and the Commissioners Court to transfer the property to the county, then operating expenses would be minimal. Fees could be charged for meeting rentals, special events, and tours. Grant money shall be explored and pursued.

Move to Action

Due to urgency of the acquisition of this important historical building, we are recommending that the Commissioners Court move swiftly to acquire this building. The cities of Mt. Vernon, Sulphur Springs, Gladewater, Talco, Jefferson, Pittsburg, and others have moved to the forefront in their preservation efforts.

Let's not be left behind.
