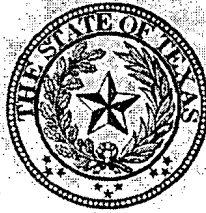

I am updating the Local Health Authority files for the counties and cities in the Texas Department of State Health Services, Health Service Region 4 & 5 North.

Our files indicate that the Titus County Health Authority, O. M. Reichert, D.O., expired on February 17, 2013. In the absence of a Local Health Authority for Titus County, the state would serve as the default Health Authority for the county. The current Regional Health Director for Health Service Region 4 & 5 North, which includes Titus County in its 35-county Region, is Paul McGaha, D.O. However, each county judge should appoint a Health Authority for his or her county.
