

ORDER 2013-2

THE STATE OF TEXAS *
COUNTY OF TITUS *

BE IT REMEMBERED that the Commissioners' Court of Titus County met in Regular Session on July 8, 2013, after notice of the meeting had been posted in the form, manner and place required by law, with a quorum of its members present and participating in the meeting when, among other matters, the following came on to be considered, and action taken thereon, to-wit:

Came on to be considered, the request of Luminant Mining Company, LLC, to temporarily close a segment of a certain county road located in Titus County, Texas, said work being more particularly described as follows:

- (1) Being identified as a segment of Titus County Road No. 2500, beginning at the south intersection of County Road No. 2520 and County Road No. Road No. 2500 and just north of the intersection of County Road No. 2500 and County Road No. 2400, and being shown as a solid yellow line on Attachment 1.
- (2) The segment of Titus County Road No. 2500 will be temporarily closed for a period of seven months after the date notice is given to the Precinct 2 Commissioner of the temporary closure. However, Luminant Mining Company, LLC, shall have one (1) year from the date of this Order to temporarily close the segment of County Road No. 2500 for the seven month period.

As a condition for the extension of the temporary closure of a certain portion of County Road No. 2500, Luminant shall, at its expense, furnish the addition of a Chip Seal coat of previously coated (black) rock for the length of existing section of County Road No. 2500 from IH-30 to the start of the 1st phase of the road relocation that occurred in 2011 (approximately 1.3 miles) and the section south of the existing bridge where the Luminant railroad crosses the road to FM 127 (approximately 1.2 miles). Additional Chip Seal will also cover the section of County Road No. 2400 between the Luminant rail spur and County Road No. 2500.

Installation of the Chip Seal coat is expected to occur by June 30, 2014, once temperatures allow for proper application.

After consideration of said request and hearing remarks from Luminant Mining Company, LLC, and interested citizens from within the county, upon motion duly made by Commissioner Fields and seconded by Commissioner Hockaday, the following Order was adopted by the Commissioners' Court of Titus County, Texas, to-wit:

IT IS, HEREBY, ORDERED BY THE COMMISSIONERS' COURT OF TITUS COUNTY, TEXAS:

That the following described segment of Titus County Road 2500 shall be temporarily closed as follows:

- (1) Being identified as a segment of Titus County Road No. 2500, beginning at the south intersection of County Road No. 2520 and County Road No. Road No. 2500 and just north of the intersection of County Road No. 2500 and County Road No. 2400, and being shown as a solid yellow line on Attachment 1.
- (2) The segment of Titus County Road No. 2500 will be temporarily closed for a period of seven months after the date notice is given to the Precinct 2 Commissioner of the temporary closure. However, Luminant Mining Company, LLC, shall have one (1) year from the date of this Order to temporarily close the segment of County Road No. 2500 for the seven month period.

IT IS FURTHER ORDERED BY THE COMMISSIONERS' COURT that Luminant shall, at its expense, furnish the addition of a Chip Seal coat of previously coated (black) rock for the length of existing section of County Road No. 2500 from IH-30 to the start of the 1st phase of the road relocation that occurred in 2011 (approximately 1.3 miles) and the section south of the existing bridge where the Luminant railroad crosses the road to FM 127 (approximately 1.2 miles). Additional Chip Seal will also cover the section of County Road No. 2400 between the Luminant rail spur and County Road No. 2500. Said installation of the Chip Seal coat shall occur by June 30, 2014, once temperatures allow for proper application.

IT IS FURTHER DETERMINED BY THE COMMISSIONERS' COURT that the interests of the public and affected landowners have been protected.


Upon a vote, all voted "aye", and none voted "no", and the County Judge declared the Order passed, approved, and adopted as of the 8th day of July, 2013.

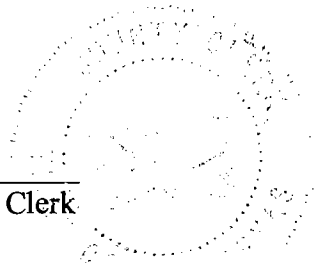

RE: Request to temporarily close a segment of County Road No. 2500 located in Titus County, Texas

Gentlemen:

Luminant Mining Company, LLC ("Luminant") has coal and lignite leases in Titus County, Texas. In order to conduct mining operations and maintenance of improvements made to the roadway described below, it will be necessary to extend the closure of a certain section of County Road No. 2500 in Titus County. Pursuant to the authority vested in the Commissioners Court under Texas Local Government Code, Sec. 81.028(2) and Texas Transportation Code, Sec. 251.051, Luminant respectfully requests the Commissioners Court of Titus County, Texas, to allow the following:

- (1) Luminant requests approval to extend the temporary closure of a segment of County Road No. 2500, beginning at the south intersection of County Road No. 2520 and County Road No. 2500 and just north of the intersection of County Road No. 2500 and County Road No. 2400; said proposed road closure being marked as a solid yellow line on the map attached hereto as Attachment 1.

This segment of Titus County Road No. 2500 will be temporarily closed for a period of seven months from July 1, 2013, through January 31, 2014.

- (2) As a condition for the extension of the temporary closure of a certain portion of County Road No. 2500, Luminant shall, at its expense, furnish the addition of a Chip Seal coat of previously coated (black) rock for the length of existing section of County Road No. 2500 from IH-30 to the start of the 1st phase of the road relocation that occurred in 2011 (approximately 1.3 miles) and the section south of the existing bridge where the Luminant railroad crosses the road to FM 127 (approximately 1.2 miles). Additional Chip Seal will also cover the section of County Road No. 2400 between the Luminant rail spur and County Road No. 2500.

Installation of the Chip Seal coat is expected to occur by June 30, 2014, once temperatures allow for proper application.

Luminant requests that the Commissioners Court of Titus County, Texas, adopt and enter an order which extends the temporary closing of the segment of County Road No. 2500 in accordance with the terms provided herein.


In the event that there are individuals living on lands in the vicinity of the road for which closure is being requested, no such resident or landowner will be denied access to their property.
