Pleasant, Texas, to take up for consideration the following topics:

PLEDGE OF ALLEGIANCE

1. Open a Public Hearing to present information and receive public comments on the following topics:
  - a. Whether or not to create one or more County Energy Transportation Reinvestment Zone (CETRZ), as authorized by law, to promote one or more infrastructure projects to be located within the County to be funded by the CETRZ.   - b. The potential boundaries and requirements of a County Energy Transportation Reinvestment Zone (CETRZ), as authorized §222.1071 of the Texas Transportation Code.
2. The Commissioners' Court may, 30 days after closing the Public Hearing, take appropriate action on the matter, as the Commissioners' Court may in its discretion determine to be in the best interest of the County.


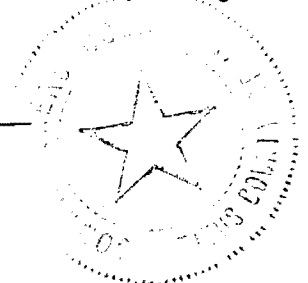
