What is on the ballot?

Prop 1: Keeping a Tax Cap & Allowing Voter Approved Repairs

Proposition 1 keeps a 10 cent Tax Cap for maintenance and operation costs but allows for voter approval of repair, restoration and improvement bonds.

Prop 2: Funding Repairs for EXISTING classrooms

Proposition 2 requires passage of Proposition 1. It calls for voter approval of \$19.9 in bonds to fund repair of EXISTING college classrooms and infrastructure that are broken or worn out. If voters approve Props 1 and 2, then the net effective tax rate would increase by 3.6 cents per \$100 valuation.

If Props 1 and 2 receive voter approval, the NEW community college tax rate will be dedicated to the following:


7.3 cents For maintenance and operation'

2.7 cents For retirement of 2002 voter approved bonds"

3.6 cents For 2014 repair bonds"


13.6 cents: New community college tax rate beginning 2015

 Any increase above current maintenance and operation tax rate will be subject to a voter roll-back election

What will this mean for community members?

Camp, Morris and Titus counties comprise the Northeast district. Taxpayers in these counties would see a 3.6 cent increase per \$100 valuation on their annual property tax bill. This translates to:

A small monthly cost for local homeowners

\$50,000 Home	\$1.50/month
\$100,000 Home	\$3.00/month
\$150,000 Home	\$4.50/month
\$200,000 Home	\$6.00/month

Voters over 65 can request ballot-by-mail now Early Voting: Oct. 20-31, 2014 Election Day: Tuesday, Nov. 4th, 2014

Camp County - The Voter Registration Office in the Camp County Courthouse will be open from 8 a.m. to 5 p.m. weekdays for early voting. Applications for ballot by mail should be mailed to Elaine Young, 126 Church St., Room 102, Pittsburg, TX 75686.

Morris County - Early voting will be from 8 a.m. to noon and 1 to 5 p.m. weekdays at the Morris County Clerks Office in the courthouse, 500 Broadnax St., Suite D, Daingerfield. Applications for ballot by mail should be mailed to Elections Office, 500 Broadnax St, Ste. D., Daingerfield, TX 75638.

Titus County - Titus County Elections Administration Office will be open from 9 a.m. to 5 p.m. weekdays for early voting. Applications for ballot by mail should be mailed to Leonard Rockwell, Elections Administrator, 110 S. Madison, Suite C, Mt. Pleasant, TX 75455.
