RESOLUTION OF THE TITUS COUNTY COMMISSIONERS' COURT IN SUPPORT OF AN APPLICATION BY TITUS COUNTY TO HOST A COUNTY PROSPERITY SUMMIT OFFERED BY THE NATIONAL ASSOCIATION OF COUNTIES (NACo) FOR THE COMBINED COUNTY REGION OF THE ARK-TEX COUNCIL OF GOVERNMENTS AND NORTHEAST TEXAS COMMUNITY COLLEGE AND AUTHORIZING THE ATCOG EXECUTIVE DIRECTOR TO SUPPORT THE APPLICATION AND ASSIST IN COORDINATION OF THIS PROJECT.
