## Dear Judge Lee:

A bid for the purchase of the above referenced tract of land, which had been previously struck off at a delinquent tax auction to the City of Mt. Pleasant, as Trustee for the taxing entities of Titus County, has been received by the City from Omar Jaime. The City has accepted this bid of $\$ 2,250.00$ and will sell the property with the consent of the other entities involved. Section 34.05 of the Texas Property Tax Code requires consent by all taxing entities when such a sale is for less than the amount of the judgment and less than the tax appraisal value. The sales price for the above lot is for less than the Judgment amount of $\$ 16,241.24$ and the tax appraised value of $\$ 9,854.00$. Therefore before the sale can become final, the consent of your taxing entity by resolution is necessary.

This is a 2.433 acre wooded tract as can be seen by the enclosed aerial view. The tract is completely landlocked without any access except through adjoining landowners. The lot has been available for sale since March, 2013, when no bid was received on it at the initial Sheriff's sale. All the adjoining landowners were notified of its availability but only one has responded with a bid. That is the bid of $\$ 2,250.00$ by Omar Jaime, who owns the property which fronts on Highway 67 immediately to the north of the tract.
