Dear Commissioners,

I was advised by Sheriff Tim Ingram that one of their older patrol cars was being taken out of service and that he would like to donate it to our office if we needed it. The vehicle needs a radio, siren speaker, new decals, and tools to remove the old decals. I have received quotes for the items needed and attached them to this letter. I drove the vehicle from 4/24/15 through 4/27/15. I noticed the steering pulling some to the right and the check engine light came on so I carried it to Billy Craig's Wrecker Service to be checked. I was advised the front end needed alignment and the EGR Valve needed to be replaced. The vehicle is a 2008 Ford Crown Victoria and has 169,000 miles. I have been informed a lot of those are highway miles. The body, interior, and other equipment installed have been taken very good care of and seem to be in good working condition.

The reason I'm asking for this vehicle is because I have two Reserve Deputy Constables that each work 28 to 30 hours per week. Having only one patrol car for two deputies that work that many hours limits the amount of work we can get done. With two patrol cars, they can separate and work on different tasks at the same time.

I have to testify in a probation hearing in Linden, TX today and won't be able to make it back in time for Commissioner's Court. I apologize for my absence tonight and I appreciate your consideration in this matter.

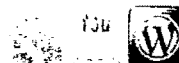

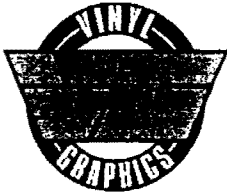

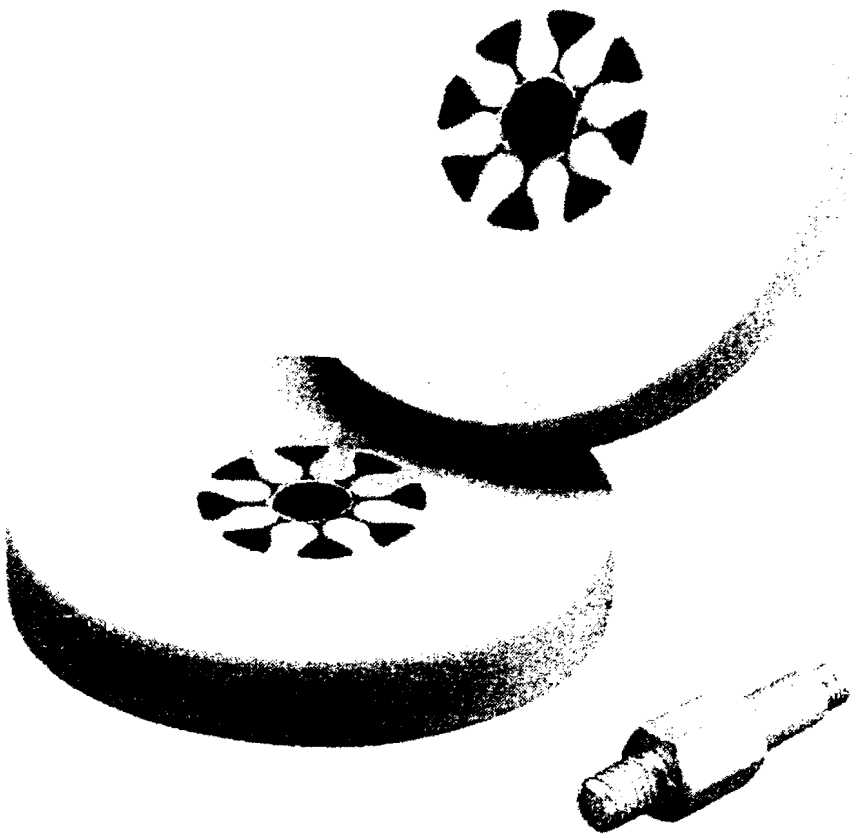
