Member rebates

The Cooperative has a long history of issuing member rebates. Since 2006, we have rebated just over \$20.8 million to our governmental membership—a claim no other Texas-based cooperative can make. The rebate is reflective of the program's value, benefit, and nonprofit administration. In addition to the Cooperative rebate, some BuyBoard vendors also provide rebates directly to members—a double bonus!

Request for Quotes (RFQ) application

BuyBoard's RFQ functionality allows members to request pricing on volume needs from multiple vendors. This convenient and efficient process can be finalized in a matter of days, versus weeks or months, for a typical formal bid/proposal.

Member governed

The Cooperative is governed by an 11-member board of directors, the majority of whom are purchasing professionals that represent members from schools, cities, and counties. The board's only function is to govern the Cooperative and award all contracts directly with no delegation of authority to staff. Because all contracts are advertised and solicited directly, no lead agency is involved.

Support of public education and local governments

BuyBoard was created to support and serve public schools, municipalities, counties, and all types of local government agencies and nonprofits. That support and service is evidenced in the list of organizations that endorse the program and in turn support their respective membership. Purchasing through the BuyBoard means your agency is helping to support the statewide organizations that support you.

Purchasing made easy

As easy as 1-2-3...

1. Identify the vendors and/or products you need.
2. If necessary, call the vendor and request a "BuyBoard Quote." The other option is to use the RFQ function to request pricing from multiple vendors.
3. Issue your PO in the name of the vendor, indicate on the PO "Per BuyBoard Contract," and fax or e-mail to the following:

Purchase order compliance

When using BuyBoard, your purchase order (PO) must be documented in the BuyBoard system. This is important for a number of reasons:

Bid Compliance—If you are questioned about a specific purchase, use of the BuyBoard serves as documentation that the purchase was made through the Cooperative. With no documentation, the assumption is that the order was not made using the BuyBoard contracts.

Documented Audit Trail—BuyBoard provides a documented audit trail for auditors to reference when determining if local or state procurement requirements were satisfied.

Rebate Credit—If purchase orders are not accounted for in the BuyBoard, then any potential rebate is lost.

Additional options for PO compliance

Monthly PO Report—Members can submit a monthly PO report that is uploaded into the BuyBoard to document PO activity. This usually starts with identifying the vendors being used under the BuyBoard contracts and flagging them in the financial/purchasing system. The PO activity is then exported to an Excel spreadsheet template and e-mailed to the BuyBoard. (Contact us if you would like the Excel template.)

BuyBoard Website—Each user has a security role, defined by the entity, which allows the user to shop and/or transmit a PO to the vendor. Individuals who have this role can attach their organization's actual PO to the BuyBoard header information and transmit the PO to the vendor through the BuyBoard system. This automatically documents the PO in the BuyBoard.

Important reminders

- Always try to mark your PO with "Per BuyBoard" to avoid confusion.
- If the PO was previously sent to the vendor, please mark with "Record Only or Confirming Copy."
- We can accept vendor invoices and credit card or P-card statements as long as each indicates the vendor name, amount spent, and what was purchased.
- If you don't use purchase orders, we can accept a signed letter of authorization or signed proposal or quote.
- We can accept purchase information for orders as old as 90 days.
- Check the PO Status Report frequently to see if any are missing.
- BuyBoard Quarterly Reports, mailed each quarter, help you confirm that all purchases for the last 90 days have been reported. If any are missing, send us a copy of the transaction(s).

Compliance is essential when buying through BuyBoard—but the steps are short and simple! Our goal is not only to keep you in compliance with state and local procurement requirements but also to help you maximize your BuyBoard rebate. **Remember, if BuyBoard isn't notified, you will lose rebate dollars.**

It's Just That Simple!



PURCHASE ORDER PROCESSING

Each organization has its own policies and procedures when it comes to spending money. BuyBoard is designed as a tool to support our members and help meet your purchasing needs.

After you have identified a need, you may browse all awarded items online via BuyBoard's secure website, www.buyboard.com.

There are three options available to search the BuyBoard for product and pricing information. The first is using a search term which will return all item descriptions and pricing sheets containing the search term. The search feature will return any portion of the term found in the following; Vendor Name, Item Description, Part Number, Brand, or the pricing sheet (PDF documents provided by the vendor that contain catalog or price pages). The second option is to search by vendor. The third is to browse vendor discounts which will display the entire list of commodities with associated contract categories. This results in the percentage discounts offered by the vendors off their published catalog or list price.

As a general rule, there are two simple processes to use the BuyBoard correctly. Regardless of which process you select, purchase orders should be in accordance with your organization's guidelines. Purchase orders are always issued in the name of the vendor.

Option 1:

- If the product can be purchased as is, and the pricing is posted on the BuyBoard, and the item does not have options or need any configuration that requires interaction with the vendor then follow the steps below:
 1. Identify the vendor or product from the BuyBoard
 2. Process a purchase order in accordance with your organization's guidelines. Issue the purchase order in the name of the vendor.
 3. Fax the signed purchase order to BuyBoard at 800.211.5454 or email to info@buyboard.com. You also can transmit a copy of your organization's purchase order electronically on the BuyBoard as another option. In order to transmit the order online you must have a certain security role and authority. Check with your administration to confirm.

Option 2:

- If the product does not have pricing posted or requires some interaction with the vendor to configure or add options then the process is as follows:
 1. Identify the vendor or product from the BuyBoard
 2. Contact the vendor and let them know you need BuyBoard pricing
 - a) Tell the vendor what you need
 - b) Obtain a written quote from the vendor
 - c) Make sure the item quoted is part of the BuyBoard contract
 3. Process a purchase order in accordance with your organization's guidelines. Issue the purchase order in the name of the vendor.
 4. Fax the signed purchase order to BuyBoard at 800.211.5454 or email to info@buyboard.com. You also can transmit a copy of your organizations purchase order electronically on the BuyBoard as another option. In order to transmit the order online you must have a certain security role and authority. Check with your administration to confirm.

That's it! In reality it only takes three (3) or four (4) easy steps to complete the process.

The preferred method is for BuyBoard to receive the original purchase order. BuyBoard staff will input the order and then the BuyBoard system transmits the purchase order to the vendor. Purchase orders are processed and transmitted to the vendor within 90 minutes of receipt.

The option for you to transmit your original purchase order through the BuyBoard is also available. The process is simple and quick, but does involve attaching your original purchase order as a PDF document.

Some of our members submit orders directly to the vendor and then fax or email BuyBoard a confirming, or "record only," copy. This is fine, as long as these orders are **clearly marked** as confirmation or record only. BuyBoard staff record these purchase orders in the system but a purchase order is not transmitted to the vendor.

Keep in mind that your audit trail is not protected if purchase orders are not faxed or emailed to BuyBoard. Annual rebate credits are also lost if the BuyBoard does not have record of your purchase orders.
