



Dear Judge Lee,

According to Section 6.03 (g)" each taxing unit that is entitled to vote may nominate by resolution adopted by its governing body one candidate for each position to be filled on the board of directors" of the Titus County Appraisal District. The presiding officer of the governing body of the unit **shall submit the names** of the unit's nominees to the Chief Appraiser **before October 15<sup>th</sup>**.


Section 6.03 (j) states **before October 30** the Chief Appraiser shall prepare a **ballot listing the candidates** whose names were timely submitted alphabetically according to the first letter in each candidate's surname, and shall deliver a copy of the ballot to the governing body of each taxing unit that is entitled to vote.

Section 6.03 (k) The **governing body** of each taxing unit entitled to vote shall **determine its vote** by resolution and **submit it** to the chief appraiser **before December 15<sup>th</sup>**. The chief appraiser shall count the votes, declare the five candidates who receive the largest cumulative vote totals elected, and **submit the results before December 31<sup>st</sup>** to the governing body of each taxing unit that is entitled to vote. If a tie occurs the chief appraiser shall resolve a tie vote by any method of chance. Enclosed you will have the resolution for nominations by your district. **Please complete and return before October 15<sup>th</sup>**.
