WHEREAS, the Official Court Reporter of the 276<sup>th</sup> Judicial District of Texas, Linda Carroll, is presently drawing a salary of \$61,292.40 per year (5,107.70 per month) apportioned among the four counties of the District, and


WHEREAS, due to inflation in the costs of living, and in order to confirm her salary to that of Official Court Reporters serving a similar population and with a like work load, the Court deems it necessary and appropriate that the salary should be increased \$102.15 a month or an increase of \$1,225.80 per year, making a salary of \$62,518.20 per year, or \$5,209.85 per month, commencing on October 1, 2016 and to be apportioned among the four counties on a per monthly basis as follows:

CAMP COUNTY .....	\$ 989.87
MARION COUNTY .....	\$ 885.68
MORRIS COUNTY .....	\$ 1,041.97
TITUS COUNTY .....	\$ 2,292.33

This Order is entered pursuant to and in conformity with the provisions of Section 52.051, Government Code of the State of Texas, this 2<sup>ND</sup> day of September 2016.






