### 1. PUBLIC COMMENTS AND/OR REQUESTS FOR INFORMATION ON NON-AGENDA ITEMS IN ACCORDANCE WITH SECTION 551.042, TEXAS OPEN MEETINGS

There were none.

### 2. CONSIDER AND POSSIBLY APPROVE MINUTES FROM FEBRUARY 27, 2017 SPECIAL MEETING OF THE COMMISSIONERS' COURT

Motion was made by Commissioner Parker and seconded by Commissioner Fields to approve minutes from February 27, 2017 special meeting of the Commissioners' Court. Motion passed unanimously.

### 3. <u>DISCUSS AND POSSIBLY TAKE ACTION ON FIRE PROTECTION OPTIONS FOR THE</u> COUNTY

Judge Lee gave a recap of the last 18 months regarding fire protection options for the county and directed the Court's attention to a letter from the City of Mount Pleasant and their proposal as a result of a recent fire consultant study. (SEE ATTACHMENT 1) The county currently pays approximately \$490,000.00 yearly with an annual CPI adjustment which specifies that the city respond with two (2) firefighters on two (2) trucks. Comments were heard from Volunteer Fire Chief Jerry Clark pertaining to fire protection options for the county and the volunteer fire departments.

Motion was made by Commissioner Mike Fields and seconded by Commissioner Jimmy Parker that Judge Lee and Commissioner Parker meet with City Manager, Mike Ahrens, regarding negotiations and proposal from the City to meet the fire protection needs for Titus County. Motion passed unanimously.

## 4. <u>CONSIDER AND POSSIBLY APPROVE A SAFETY STATEMENT AT THE RECOMMENDATION OF OUR INSURANCE COMPANY RISK CONTROL CONSULTANT</u>

Motion was made by Commissioner Riddle and seconded by Commissioner Fields to approve the Titus County Safety Statement at the recommendation of our insurance company risk control consultant. Motion passed unanimously. (SEE ATTACHMENT 2)

### 5. CONSIDER AND POSSIBLY APPROVE A PLAN TO PREPARE AN OFFICE FOR THE ROAD ENGINEER AT THE MAINTENANCE BARN

Motion was made by Commissioner Parker and seconded by Commissioner Applewhite to approve preparing an office for the Road Engineer at the Maintenance Barn of Precinct 1 and buying office supplies as needed. Motion passed unanimously.

### 6. PRESENTATION BY HUDSON OLD, TITUS COUNTY REPRESENTATIVE TO THE NORTH EAST TEXAS REGIONAL MOBILITY AUTHORITY

Hudson Old came to the podium and reported on the North East Texas Regional Mobility Authority stating that their main focus is in Smith County. He encouraged members of the Commissioners' Court to attend one of the meetings and to also invite Chris Miller, Executive Director, to attend Commissioners' Court to answer any questions that Titus County may have regarding future projects.
