Dear Judge Lee:

In reviewing the current inspection report and load rating calculations, it was determined by the TxDOT Bridge Division according to the guidelines found in TxDOT's Bridge Inspection Manual set by the Federal Highway Administration, the bridge on CR 4754 over Williamson Creek needs to be closed to traffic as soon as possible. Please notify Randell DeLoach at randell.deloach@txdot.gov when this bridge closure has been accomplished. This bridge will need to remain closed until it can be repaired or replaced. Failure to follow closure recommendations could result in the loss of federal funds.

Through the Federal Highway Administration's Highway Bridge Program, this structure is already funded for replacement in 2021. Because of the closure, we will work with TxDOT Bridge Division to possibly advance the letting of this project.

Notice of Titus County Road Closure
