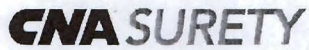
then this obligation to be void, otherwise to remain in full force and effect.

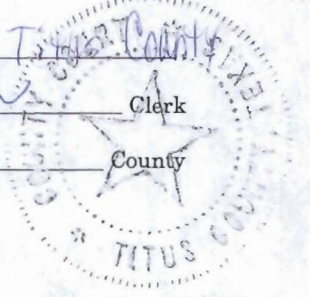
