

DESCRIPTION OF PROPERTY

Being a tract of land located in the John Thompson Survey, Abstract No. 566, Titus County, Texas, and being all of a 1.000 acre tract conveyed to the Farmers Academy Cemetery in a Deed known as Instrument No. 20173046 of the Public Records of Titus County, Texas, and being more particularly described as follows:

Beginning at a 1/2" iron rod with a cap marked "Hampton" found at the southwest corner of said 1.000 acre tract and the southeast corner of a called 3/4 acre tract conveyed to Robert J. Deane, JR. and wife, Connie R. Deane in a Deed found in Volume 561, Page 103 of the Deed Records of Titus County, Texas, the same lying in the northern right-of-way line of Interstate Highway No. 30 and in the north line of a called 10.287 acre tract conveyed to the State of Texas in a Deed found in Volume 268, Page 63 of the Deed Records of Titus County, Texas;

Thence North 00°32'42" West, generally along a chain link fence, along the west line of said 1.000 acre tract and the east line of said 3/4 acre tract, passing the northeast corner of said 3/4 acre tract and the southeast corner of a called one acre tract conveyed to O.C. Capel, et al, Trustees for the Farmers Academy Cemetery in a Deed found in Volume 153, Page 565 of the Deed Records of Titus County, Texas, then continuing on along the east line of said one acre tract and at a distance of 467.50 feet passing a 1/2" iron rod with a cap marked "Hampton" found, then continuing on for a total distance of 468.98 feet to a point for corner at the northwest corner of said 1.000 tract and the northeast corner of said one acre tract, the same lying in the southern right-of-way line of U.S. Highway No, 67 and the south line of a called 8.58 acre tract conveyed to the State of Texas in a Deed found in Volume 101, Page 263 of the Deed Records of Titus County, Texas;

Thence North 88°42'53" East along the south line of last said right-of-way and said 8.58 acre tract and the north line of said 1.000 tract for a distance of 96.71 feet to a 1/2" iron rod with a cap marked "Denney" found at the northeast corner of said 1.000 acre tract and the northwest corner of the remainder of a called 7 acre tract conveyed to JDM Contracting, LLC in a Deed known as Instrument No. 20102413 of the Real Property Records of Titus County, Texas,

Thence South 00°32'42" East along the east line of said 1.000 acre tract and the west line of the remainer of said 7 acre tract for a distance of 431.91 feet to a 1/2" iron rod with a cap marked "Denney" found at the southeast corner of said 1.000 acre tract and the southwest corner of the remainder of said 7 acre tract, the same lying in the north line of first said right-of-way and said 10.287 acre tract, from which a 1/2" iron rod with a cap marked "Hampton" found at the eastern corner of a called one-half acre tract conveyed to William Troy Owens in a Deed found in Volume 449, Page 780 of the Deed Records of Titus County, Texas, and at the point where the southern right-of-way line of HW 67 intersects the northern right-of-way line of IH 30, the same lying in the south line of said 8.58 acre tract, bears North 67°50'20" East a distance of 1099.55 feet;

Thence South 67°50'20" West along the south line of said 1.000 acre tract and the northern line of said 10.287 acre tract and first said right-of-way for a distance of 104.02 feet to the place of beginning, and containing 1.000 acres of land.
