Memorandum of Understanding

This Memorandum of Understanding is made on February 26, 2018, by and between Franklin County, Texas and Titus County, Texas, for the purpose of transferring goods from the closed Franklin County Hospital to Titus County.

The goods in question, which are on the following documents prepared by Shannon J. Cox-Kelley EdD, MS, MICHES, CPH, Dean of Health Sciences, from Northeast Texas Community College in Mount Pleasant, Texas are to be allocated to Titus County, who in turn will transfer the goods to the College.

- 1 Bathroom Sink For Handwashing in Training Lab and Infection Control
- Autoclave w/Boiler To Sterilize Cadaver Lab Instruments and Control Biohazard Waste
- EMR Cow To Allow for EMR Records and Files in the Cadaver Lab, Mimic EMR Procedures in Workplace
- 2 Procedure Overhead Lights -- For Cadaver Lab Dissection and Education
- Kitchen Sink and Table Combo For Student Body and Staff Service
- Miscellaneous Supplies Gauze, Suction Tubing, Cannulas, Disposable Endo Trachs, and IV Sets for Student Practice and Patient Simulation
