Dear Commissioners:

On August 22, 2016 the Titus County Commissioner's Court based on petitions submitted by interested people in Titus County called a special election to allow the voters of Titus County to decide on adopting the "Optional County Road System in Titus County". The special election was held resulting in the adoption of said system.

Since the adoption of the Optional County Road System, the people of Titus County have had an opportunity to discover that the implementation of the system has resulted in increased costs of hiring personnel to operate the road system, the reduction of the amount of mileage of roads that are repaired and constructed in Titus County each year, and therefore the inefficiency of the use of Titus County tax dollars in funding this road system.

Section 252.301 (d) of the Texas Transportation Code provides that "A county that votes to adopt this subchapter may vote in the same manner to discontinue use of this subchapter."

We, the citizens of Titus County whose signatures are attached hereto, therefore, respectfully request that an election to discontinue Titus County's use of the Optional County Road System be called at the earliest possible date under the terms and conditions of the Texas Transportation Code.
