RESOLUTION NO. 2019-04

A RESOLUTION OF THE COMMISSIONERS COURT OF TITUS COUNTY, STATE OF TEXAS, EXPRESSING SUPPORT FOR HB 1837, WHICH DESIGNATES THE PORTION OF U.S. HIGHWAY 67 IN TITUS COUNTY BETWEEN ITS INTERSECTION WITH FARM-TO-MARKET ROAD 2348 AND THE EASTERN MUNICIPAL BOUNDARY OF MOUNT PLEASANT IS DESIGNATED AS THE TITUS COUNTY WORLD WAR II VETERANS MEMORIAL HIGHWAY.

WHEREAS, Representative Cole Hefner has introduced a bill to be enacted by the legislature of the State of Texas designating the portion of U.S. Highway 67 in Titus County between its intersection with Farm-to-Market Road 2348 and the eastern municipal boundary of Mount Pleasant is designated as the Titus County World War II Veterans Memorial Highway; and

WHEREAS, the Commissioners Court of Titus County, State of Texas, recognizes the importance of honoring our local military veterans; and

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSIONERS COURT OF THE COUNTY OF TITUS, STATE OF TEXAS, THAT the County of Titus, State of Texas, expresses its full support for designating the portion of U.S. Highway 67 in Titus County between its intersection with Farm-to-Market Road 2348 and the eastern municipal boundary of Mount Pleasant is designated as the Titus County World War II Veterans Memorial Highway, and respectfully requests the Texas Legislature vote to enact this bill.

A BILL TO BE ENTITLED

- 1-1 AN ACT
 1-2 relating to the designation of a portion of U.S.
 Highway 67 in Titus
- 1-3 County as the Titus County World War II Veterans Memorial Highway.
- 1-4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 1-5 SECTION 1. Subchapter B, Chapter 225, Transportation Code,
- 1-6 is amended by adding Section 225.152 to read as
 follows:
- 1-7 <u>Sec. 225.152. TITUS COUNTY WORLD WAR II</u> <u>VETERANS MEMORIAL</u>
- 1-8 <u>HIGHWAY. (a) The portion of U.S. Highway 67 in Titus</u> <u>County</u>
- 1-9 <u>between its intersection with Farm-to-Market Road 2348</u> and the
- 1-10 <u>eastern municipal boundary of Mount Pleasant is</u> <u>designated as the</u>
- 1-11 <u>Titus County World War II Veterans Memorial Highway.</u>
- 1-12 (b) Subject to Section 225.021(c), the department shall:
- 1-13 (1) design and construct markers indicating the
- 1-14 <u>designation as the Titus County World War II Veterans</u> <u>Memorial</u>
- 1-15 Highway and any other appropriate information; and
- 1-16 (2) erect a marker at each end of the highway and at
- 1-17 appropriate intermediate sites along the highway.
- 1-18 SECTION 2. This Act takes effect September 1, 2019.
