It is fully understood that consenting to the State of Florida Department of Transportation and/or its assignee, shall not relieve this surety company of any of its obligations under its bond.

In connection with obligations in favor of the Kentucky Department of Highways only, it is agreed that the power and authority hereby given to the Attorney-in-Fact cannot be modified or revoked unless prior written personal notice of such intent has been given to the Commissioner-Department of Highways of the Commonwealth of Kentucky at least thirty (30) days prior to the modification or revocation.



WHEREAS, the office of County Auditor for Titus County, Texas has heretofore been established in conformity with law, it is the duty of the District Judges having jurisdiction in Titus County, Texas to appoint a County Auditor; and

WHEREAS, the compensation of the County Auditor for Titus County Texas, has been set by law.

Now, therefore, we, Robert M. Rolston and Angela Saucier Judges of the 276th and 76th Judicial Districts, the Courts having jurisdiction in Titus County, Texas do hereby appoint BARBARA SHURBET, a qualified person, as County auditor of Titus County, Texas; and she shall, before entering upon the duties of said office take and subscribe the oaths prescribed by law, as set forth in Section 84.007 of the Local Government Code, and enter into a bond as therein provided, payable and conditioned as prescribed by law, and upon qualifying, shall hold said office and discharge the duties thereof for a term of two (2) years beginning October 1, 2019 and expiring September 30, 2021.


