RE: Response to Request under the Texas Public Information Act

Dear Mr. Crowder:

This letter is in response to your Request under the Texas Public Information Act that you hand-delivered to Michael Russell, President of Sulphur River Basin Authority ("SRBA") on August 19, 2014. This response is in accordance with V.T.C.A., Government Code, Chapter 552, Texas Public Information Act (hereinafter referred to as "the Act").

In your Request you stated that you are requesting that SRBA provide you with any and all technical information and data that SRBA possesses concerning the Marvin Nichols project, specifically, any and all geological and engineering studies. SRBA has made a preliminary review of its files regarding the information you have requested, and has determined that documents responsive to your Request are available unless exempted by the terms of said Act.

SRBA is willing to produce the information in its records that you have requested, subject to payment of the costs detailed below. A substantial part of the information you have requested is either in active use or in storage, and I certify that such information cannot be produced for inspection or duplication within 10 business days from the receipt of your request. The information you have requested will be available for inspection or duplication on October 15, 2014, at the office of SRBA located at 911 North Bishop Street, Suite C-104, Wake Village, Texas, between the hours of 9 a.m. and 4 p.m.

In accordance with Sections 552.261, 552.2615, 552.271 and 552.275 of the Act and Title I, Part 3, Chapter 70 of the Texas Administrative Code (hereinafter referred to as "the Code"), SRBA has the right to charge you all costs relating to reproducing the requested public information, including the costs of materials, labor and overhead. Said costs provided for in Rule 70.3 of the Code are as follows:

1. Copy charges. The charge for standard paper copies reproduced by means of an office machine copier or a computer printer is \$.10 per page or part of a page. The charge for oversize paper copies is \$.50 per page. Each side that has recorded information is considered a page.
2. Labor costs. The labor charge for locating, compiling and reproducing the requested information is \$15 an hour.
3. Overheard charges. The overhead charge is computed at 20% of the charge made to cover labor costs.
4. Miscellaneous supplies. This is the actual cost of miscellaneous supplies, such as labels, boxes and other supplies, used to produce the requested information.

SRBA estimates that, in order to comply with your Request, there will be 7,500 pages of standard paper copies for a cost of \$750 and 50 oversize paper copies for a cost of \$25. SRBA estimates that it will incur 174 hours of labor, resulting in a cost of \$2,610, overhead cost of \$522, and \$50 for miscellaneous supplies, for a total estimated charge of \$3,957.


Section 552.263 of the Act provides that you are required to make a deposit or post a bond for payment of the anticipated cost of \$3,957. You are advised that if you fail to make a deposit or post a bond covering said cost within 10 business days from the date of this letter, your Request under the Texas Public Information Act will be considered to have been withdrawn.

You are advised that Section 552.113(a)(2) of the Act provides that geological or geophysical information, except information filed in connection with an application or proceeding before an agency, is exempt from disclosure. SRBA requests clarification as to whether the scope of your Request includes information subject to the attorney-client privilege. If so, SRBA will need to seek an open records determination from the Attorney General with respect to the release of such material.

This response to your Request under the Texas Public Information Act is being sent to you via the following methods: (1) regular mail; and (2) certified mail, return receipt requested.
