These requirements are met by the following reports:


- 1) Combined Statement of Cash Position (GEL 102) and





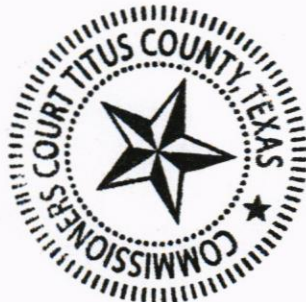
