Update on Bids to be Considered in June 2020

May 11, 2020

This information is being provided to commissioners and to the public in an effort to ascertain that all are aware of the due dates for the bids.

BACKGROUND & HISTORY

For many years, the business manager was responsible for preparing the bids. Due to the fact that the business manager position was dissolved during the deliberations for the 2020 budget, Judge Lee asked me if the auditor's office would be able to prepare these bids.

RESEARCH INTO BEST PRACTICES

In reviewing the prior year agendas, visiting with Titus County leadership and evaluating the previous procedures, I determined that there were some options available to us to streamline the bid process. I also contacted Hopkins County and Morris County to learn how other local counties were handling the bid process. I learned that we could accept the bids, open them, prepare a spreadsheet (bid tabulation) with the results, and then provide the information to Commissioners' Court for consideration. John Mark Cobern confirmed that this process was a legal method to follow. He did suggest that the bidders be allowed to attend the bid opening; therefore, each bid document includes an invitation to each bidder to attend the bid opening.

CURRENTLY ADVERTISED BIDS & DUE DATES

The **fuel bid** for gasoline and diesel as well as the **HVAC maintenance program bid** were published in the TRIBUNE on May 2 and May 9 and the deadline to return these two bids is **4:30 pm on May 19, 2020**. Bids will be opened on May 20 at 9:00 and 10:00 am respectively.

The **lawn maintenance bid** as well as the **road materials, road oil and culverts bid** were published in the TRIBUNE on May 9 and will be published on May 16. The deadline to return these two bids is **4:30 pm on May 27, 2020**. Bids will be opened on May 28 at 9:00 and 10:00 am respectively.

Each commissioner, the county judge and the county attorney received copies of the bid packets before they were released to the public.

PLANS FOR BID APPROVAL

I will prepare a bid tabulation summary for each item included in the bids for submission to commissioners' court. The bids returned in a timely manner will be available for commissioners and the county judge to review prior to court.
