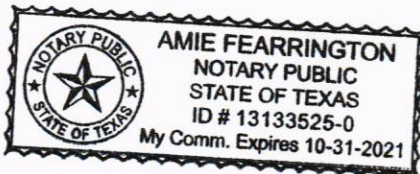

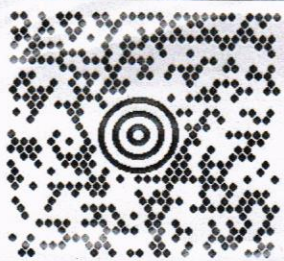

A. Scope of Bid

B. Conditions

1. Term of Contract: Upon acceptance and approval by the Commissioners' Court this bid affects a working contract between Titus County and the successful bidder for **1 year with option to renew for 2 additional years upon agreement by vendor and County. Bids are initially effective July 1, 2020.**

3. Titus County reserves the right to accept or reject in part or in whole any bids submitted, and to waive any technicalities for the best interest of the County. 4. Titus County shall not be responsible for any verbal communication between any employee of the County and any potential bidder. Only written specifications and written price quotations will be considered.

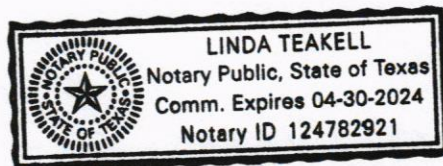
