WHEREAS, the Official Court Reporter of the 76th Judicial District of Texas, Cresta LeFevre, is presently drawing a salary \$66,344.88 per year (\$5,528.74 per month) apportioned among the three counties of the District, and


WHEREAS, due to inflation in the costs of living, and in order to confirm her salary to that of Official Court Reporters serving a similar population and with a like work load, the Court deems it necessary and appropriate that the salary should be increased \$110.57 a month or an increase of \$1,326.84 per year, making a salary of \$67,671.72 per year, or \$5,639.31 per month, commencing on October 1, 2020 and to be apportioned among the three counties on a per monthly basis as follows:

CAMP COUNTY \$ 1,297.05
MORRIS COUNTY \$ 1,353.43
TITUS COUNTY \$ 2,988.83


