Sheriff Tim Ingram has been housing federal inmates due to the fact that the Fanin County Jail is full. He currently has approximately								
30 federal inmates and is anticipating 8 additional inmates during the next few weeks. Further, Titus County may be asked to house an								
additional number of inmates up to approximately 45. Titus County receives \$45 per day for housing these inmates. Sheriff Ingram								
estimates that he will need 2 to 3 more jailers in order to house these federal inmates.								
The original revenue budgeted in this line item was for inmates from other counties. The Titus County Jail has housed very few inmates for								
local counties this year, and Sheriff Ingram anticipates housing very few inmates from other counties. Therefore, the name of this								
item has been updated to Inmate Housing - Federal.								
The line item for jailers reflects the estimated salaries for 3 jailers plus related benefits.								
The total estimated revenues for housing 45 federal inmates for one year is \$ 740,000. Sheriff Ingram estimates that he will generate								
approximately \$ 600,000 in revenues from housing federal inmates. The budgeted revenue will not be adjusted further until Sheriff								
Ingram receives additional information on the estimated number of inmates to be housed in Titus County.
