I REQUEST the county enact this work, or provide a different solution, with the contractor of your choosing.


Tenants, who had stayed after the original floodings, due to the problems of soaked carpets and walls, and unhealthy smells, moved out.

Dear Sir:

The above referenced property is the site of an office building which currently is having a drainage issue on the north side of the building.

After looking at the water damage inside the northwest corner of the building, it appears that the damage is coming from water that seeps down along the outside of the lower level north wall. The soil and sidewalk surfaces for 10' north of the wall drain southward to the wall. The 20' of soil from the northwest corner along the building is literally flat and when it rains hard for an extended period, the water fails to drain away down the slope to the east.

There needs to be a swale about half-way between the sidewalk and the north exterior wall of the building sloping to the east to allow the water to drain. A wire screen made for the open end of the pipe should be installed to keep animals from getting in the pipe and either plugging the pipe or becoming trapped themselves.
