Guaranty Bank, Mount Pleasant = 5 STAR RATING 03-31-2021.

Funds held by Titus County are invested in a sound manner with the primary focus being safety, liquidity and yield as required by the Public Funds Investment Act. See attached reports from Guaranty Bank for details on pledged securities. The current 13-week bank account interest rate was 0.03% as o 03-31-2021.

The Bank depository agreement with Guaranty Bank provides a floor on interest rates of 0.75% to 0.80% until 7-15-2021. This report is in compliance with the investment strategies in the County's Investment Policy approved January 2020 and the reporting requirements as mandated by the Public Funds Investment Act as amended.
