An election is hereby ordered to be held on **November 2, 2021**, in Titus County, Texas for voting in a special election to adopt or reject the proposed Constitutional Amendments as submitted by the 87th Legislature, Regular Session, of the State of Texas.






County Commissioner Precinct 1
(Comisionado del Condado Precinto 1)




County Commissioner Precinct 2
