WHEREAS, due to inflation in the costs of living, and in order to confirm her salary to that of Official Court Reporters serving a similar population and with a like work load, the Court deems it necessary and appropriate that the salary should be increased \$112.78 a month or an increase of \$1,353.36 per year, making a salary of \$69,025.08 per year, or \$5,752.09 per month, commencing on October 1, 2021 and to be apportioned among the four counties on a per monthly basis as follows:

MARION COUNTY ..... \$  977.85  
MORRIS COUNTY .....\$ 1,150.42  
TITUS COUNTY ..... \$ 2,530.92
