 Guaranty Bank, Mount Pleasant = 5 STAR RATING 09-30-2021.

Funds held by Titus County are invested in a sound manner with the primary focus being safety, liquidity and yield as required by the Public Funds Investment Act. See attached reports from Guaranty Bank for details on pledged securities. The current 13-week bank account interest rate was 0.04% as of 09-30-2021. The new contract with Guaranty Bank was effective 7-15-2021. The new contract does not have a floor on interest rates. This report is in compliance with the investment strategies in the County's Investment Policy approved January 2020 and the reporting requirements as mandated by the Public Funds Investment Act as amended.
