 The current 13-week bank account interest rate was 0.06% as of 12-31-2021.
 The previous depository contract with Guaranty Bank ended July 15, 2021. The new contract does not have a floor on interest rates.
 The current depository contract ends July 16, 2024.
 This report is in compliance with the investment strategies in the County's Investment Policy approved January 2020 and the reporting requirements as mandated by the Public Funds Investment Act as amended.
