Dear Judge Lee,

During the meeting held on March 7, 2022, the Board of Directors instructed me to give the taxing units notice that the Board of Directors will take action to amend the District's 2022 budget at its next meeting. The amount of the 2022 Budget Amendment is \$120,561 and represents the amount of surplus money left over from the 2021 budget year. Your taxing unit's 2022 allocation(s) will not increase if the Board of Directors amends the budget. The reason the Board of Directors wants to retain the funds and amend the 2022 budget is so that the District can better prepare for its current litigation brought by property owners. Outside appraisal reports for litigation may cost around \$15,000 per account, per year, and the District may need as many as nine reports. The District's current litigation budget is only \$23,000 and this is not sufficient to properly defend the District considering the number of cases currently pending.

I have attached a spread sheet to reflect your approximate share of the surplus which the Board is asking to retain.

The Board of Directors plan to adopt the 2022 Budget Amendment at its April 11, 2022 board meeting. If you have questions or concerns about the proposed 2022 Budget Amendment, please contact Ms. Dickerson at the number above.
