**BANK MONITORING:**

Titus County uses the Bauer Financial website to monitor bank ratings.  
 Bauer Financial has been reporting and analyzing the performance of U.S. banks since 1983.  
 Bauer Financial recommends all 5-Star and 4-Star institutions.  
 Guaranty Bank, Mount Pleasant = 5 STAR RATING 1-19-2023.

Funds held by Titus County are invested in a sound manner with the primary focus being safety, liquidity and yield as required by the Public Funds Investment Act.

The current 13-week bank account interest rate was 4.3% as of 12-30-2022.

The previous depository contract with Guaranty Bank ended July 15, 2021. The new contract does not have a floor on interest rates.

The current depository contract ends July 16, 2024.

This report is in compliance with the investment strategies in the County's Investment Policy approved September 2021 and the reporting requirements as mandated by the Public Funds Investment Act as amended.

The Public Funds Investment Act requires that banks collateralize deposits at 102% of balance.
