TITUS COUNTY COURTHOUSE GROUNDS FEBRUARY 27, 2023 MARCH____,2023

The purpose of this agenda item is to seek the approval, support and enforcement of the Titus County Commissioners, Titus County Court, County Judge and other Officers of the County Court to; prohibit, forbid and otherwise deny and refuse any request from any individual, group or entity to place or cause to have placed portable toilets, port-a-potties, Johnny-on-the-Spots or other sanitation facilities by any other name on Courthouse Grounds, without specific and written authorization of the Titus County Commissioners Court. However, In no case will such authorization allow placement of referenced facilities within 25 feet of any present or future Monument, Memorial, Tribute or Statue that is located on Courthouse Grounds at anytime.

Should any individual, group or other entity that has been properly granted permission by the Titus County Commissioners Court to hold an event on the Titus County Courthouse Grounds, violate by the action or inaction of their representative(s) and/or any third party or contracted service shall be fined no less than \$100 (one hundred dollars), per unit, per hour, per day... plus immediate removal of such facilities and possible denial of any future event approvals.

Example: Violation; 2 toilets / 2 hours / 1 day = \$400 Fine (four hundred dollars)

These fines would be held by the County and used for the care and maintenance of the Monuments, Memorials, Tributes and Statues on Titus County Courthouse Grounds, as deemed appropriate and necessary by the Titus County Commissioners Court.
