My commands are in regard to the american Rescue Plan funds allocated for Titus County. I'm here reprenoting the mon projet Taleo Historical Museum located within the Talco City

Hall building

The museum began with several Talio residents applying for a tax ID and Tax except Status in 1999-2000. In the beginning they charged a \$10.00 membership fee per year and had fund raisers to reconstruct the living quarters that usas part of the City Hall building and turn it into a museum to house and preserve the historical artifacts that represent the beginning of Houles boro settlement and which latter became the incorporated city of Jala within Titus County.

The original building was built in 1937. Some of the windows have been and doors are from the original structure and have been bounded up with plywood over the years. The city of Talue has generously allowed us to use 5 rooms and pays the utilities for the space. They have agreed for us to make updates to the area but they have no money to support the renovation needed to make the area more secure from the elements and to be hardilapped accessible. Below are the updates we would like to make:

1. Bathroom, sink and toilet replaced, running water in sink, old shower

removed and Shelving for Storage in its place.
