Hello Judge Lee and Commissioners: Please consider the possibility of placing this item on the agenda for June 12, 2023.

Judge Lee approved this grant in December, but it was not approved through Commissioners' Court. I received a copy of the grant today from Brian

Clayton. Please recall that Christie Davis, Camp County Auditor, manages

the Juvenile Probation accounting and auditing for Titus County.

This is a reimbursement grant from ATCOG for juvenile probation mental health evaluations. Christie or Brian will manage all of the reporting for this grant including the requests for reimbursement from ATCOG.
